Marty Meyette our County Commissioner presented information on Procedures for Code Red in our area. She also left cards to hand out with the information. She also reviewed a petition being circulated in Oceana County dealing with Oceana County becoming a Sanctuary County for the Second Amendment. The petitions will be presented to the Board of Commissioners in Hart on the 23<sup>rd</sup> of Jan. 2020.

A letter from the Household Hazardous Waste for Oceana County was read. They are asking for monetary support for their collections for another year. Joan David made a motion to sponsor \$50.00 to them. John Clark seconded it. The motion carried.

New Business- The Armor Gun Shop, owned by Ray Post, has been certified by the AFT to handle the paperwork for sales of guns during the auctions at the Beyer Auction located at 8016 E. Garfield Rd. Because there will be no gun sales, The Planning Commission agreed they did not need a Special Use permit to offer the same paperwork services outside of the auction. Joan David made the motion to approve this and Tami Ballantyne seconded it. The motion carried.

Tami made a motion to approve the meeting dates for 2020, as the third Tues of each month. John Clark seconded it. The motion carried.

Reports- Fireboard – The new roof is on the Fire Barn.

Planning Commission – The next meeting is May 7<sup>th</sup>.

The web page is being updated at this time.


Tami Ballantyne made a motion to have a Public Budget meeting 15 minutes before the regular meeting in February 2020. John Clark seconded it. The motion carried.
