Road work is coming.....The following roads have been approved by the Township Board.....Riverview Drive (M20-Hawley St.) using ARPA funds, Lakeview Dr. around HighTower Lake, using ARPA funds, Loop Road (192nd Ave. to village limits) using Township road funds, 176th Ave.(Loop Road to Zimmer Road) using cannabis funds, 200th Ave. (Pierce Road south to Baker) using cannabis funds, Hawley St. (Riverview Dr. to the village limits) OCRC will be finishing this project that was started last year. We will also be doing 2 brinning applications.
