The Planning Comm will be looking at a Public Hearing on the Mansfield Property on W— M20 for a possible Mining Sand and Gravel Permit at their March meeting. The notice will be published in the Oceana Echo.

Cemetery - Dennis sold 3 lots.

Zoning – Steve handed out his monthly report. Activity for the month shows a new home going in on 164^{th} . The paper work is continuing on the new Verizon Tower on the corner of 192^{nd} and Gale Rd. Mansfields excavation has turned in paperwork for a Mining Sand and Gravel operation on W – M20. They have received the contract with the village of Hesperia to supply sand and gravel for the Villages Sewer and Water Project. The public hearing will take place at the Planning Comm. Meeting in March to

be presented to the board at the March 18th meeting. The plan is to mine for 2 or 3 years then turn it into 3 lots around a pond for housing, with a spec house going in.

Several Civil Infraction notices were sent out. One resident responded. He will be meeting with the Infraction Board on Wednesday the 19^{th} of February , 2025.
