## Reports:

MTA- Joan met in Lansing two weeks ago for a State MTA meeting. The next Oceana County MTA will meet January 29<sup>th</sup> at 6:00 p.m. in Shelby.

The spring State Conference will be in Grand Rapids March 31 to April 3<sup>rd</sup>. Please let Joan know if you plan on attending before Dec. 31<sup>st</sup> so reservations can be made.

Planning Commission- Steve stated that we finished the new Master Plan and now will be revisiting and updating the new Zoning Ordinance. The next Planning Comm meeting will be January 14,2024.

Marijuana Enforcer – All permits have been turned in to the township along with the appropriate Money per permit.

Cemetery- Dennis made 1 base this month. One resident questioned if they could pay for plowing in the cemetery during the winter. Dennis stated that there are two reasons we will not allow plowing in the winter. We just had the roadways in the cemetery regroomed and graveled. In the past stones have been damaged because of being hidden by snow. The resident was told no.

Zoning – Steve handed out his December report to the board. He reported this past year we had 9 parcel s split. In following up on several complaints we have been working on , we will be writing citations in the new year.

## **Public Comments-**

There were several comments.

Board Discussion- Wayne Ferris went over information he received from the last training he attended. 1) The state will be placing more of a workload on the townships clerk, this next year. 2) Townships need

to decide who is eligible to contact the Township attorney.3) The township is not required to take bids on any work to be done.

Mary Hopkins will be taking the same training online on the 20<sup>th</sup>.

They suggested that Special meetings be run like a Town forum.

Paul Erickson our County Commissioner stated the County Board will be voting on someone to take Phil Morses spot on the board.

The Cannabis Enforcer stated he would be willing to meet with our new board member Micah Johnson, to review procedures used when reviewing them. Steve Micklin also stated he would be willing to show him the procedures and processes used in evaluations, etc..

Nancy Conley made a motion to adjourn. Seconded by Wayne Ferris. The motion carried. The meeting was adjourned at 7:43 p.m.
